 - c. Discussion regarding possible negotiations to sell airport property.

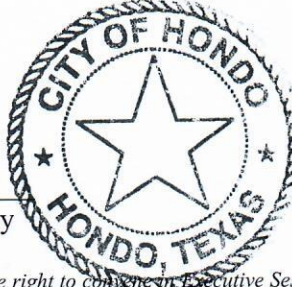
