Discuss and consider a request from Gaylon and Farrah Schueling on a short form subdivision replat of 0.591 acres into Lots 1 and 2 out of Block 10, Barkuloo South End Addition in the City of Hondo. The parcel of land is situated north of 30th Street between Ave G and Ave H and its current address is 702 30th Street. (Gilbert Contreras)
