Discuss and consider approval of Ordinance No.1116-12-16, an ordinance of the City of Hondo, Texas authorizing the issuance of "City of Hondo, Texas combination tax and subordinate lien revenue certificates of obligation, series 2017"; providing for the payment of said certificates by the levy of an ad valorem tax upon all taxable property within the city and further securing said certificates by a lien on and pledge of the pledged revenues of the system; providing the terms and conditions of said certificates and resolving other matters incident and relating to the issuance, payment, security, sale, and delivery of said certificates, including the approval of an application to the Texas Water Development Board and a private placement memorandum pertaining to the bonds; authorizing the execution of a paying agent/registrar agreement, and an escrow agreement; complying with the requirements of the letter of representations on file with the Depository Trust Company; authorizing the execution of any necessary engagement agreements with the City's Financial Advisors and/or Bond Counsel; and providing an effective date.
