

ORDINANCE NO. 1121-03-17

AN ORDINANCE OF THE CITY OF HONDO, TEXAS (CITY) AMENDING ORDINANCE 1106-09-16 “FEE SCHEDULE” BY ESTABLISHING SENIOR DISCOUNT FOR POOL RECREATION MEMBERSHIPS AND POOL PASSES; DECLARING A PUBLIC PURPOSE; INCORPORATING RECITALS; PROVIDING A REPEALER; PROVIDING FOR SEVERABILITY AND SETTING AND EFFECTIVE DATE.

WHEREAS, the City of Hondo adopted Ordinance 1080-09-15 on September 28, 2015, which amended the City Code to include a comprehensive “Fee Schedule” and set forth the cost of all services provided to the citizens and businesses of the City; and

WHEREAS, the City of Hondo City Council considers it reasonable to amend said Fee Schedule periodically to reflect the cost of providing services; and

WHEREAS, the City of Hondo City Council approved Ordinance 1106-09-16 revising municipal swimming pool fees in the Fee Schedule; and

WHEREAS, the City Council has determined it is necessary to further amend the Fee Schedule to establish senior discounts for Pool Recreation Memberships and Pool Pass Options; and

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HONDO, TEXAS

SECTION 1. AUTHORIZATION. The City of Hondo has adopted municipal Swimming Pool Fees in Article A1.001 “General Provisions” section of the Fee Schedule and now wishes to revising the fee schedule as follows add a Senior Discount of 10% to recreation membership and swimming pool pass fees. The revised Swimming Pool fee schedule is included in Exhibit “A” and made part of this ordinance and to be set forth in the City of Hondo Code of Ordinances as Appendix A.

SECTION 2. PUBLIC PURPOSE. The City declares the revision of its municipal fees and charges is in the public interest.


SECTION 3. REPEALER. All ordinances, resolutions, and municipal orders in conflict herewith are repealed to the extent of such conflict.

SECTION 4. SEVERABILITY. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or illegal, such decision shall not affect the validity of the remaining sections of this Ordinance. The City Council hereby declares that it would have passed this Ordinance, and each section, subsection, clause, or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared void; and that in lieu of each clause or provision of this Ordinance that is invalid, illegal, or unenforceable there be added by the Mayor as necessary with the approval of the City Attorney

as to form, and as a part of the Ordinance a clause or provision as similar in terms to such invalid, illegal or unenforceable clause or provision as may be possible, legal, valid and enforceable.

SECTION 5. EFFECTIVE DATE. This ordinance shall take effect upon passage.
