

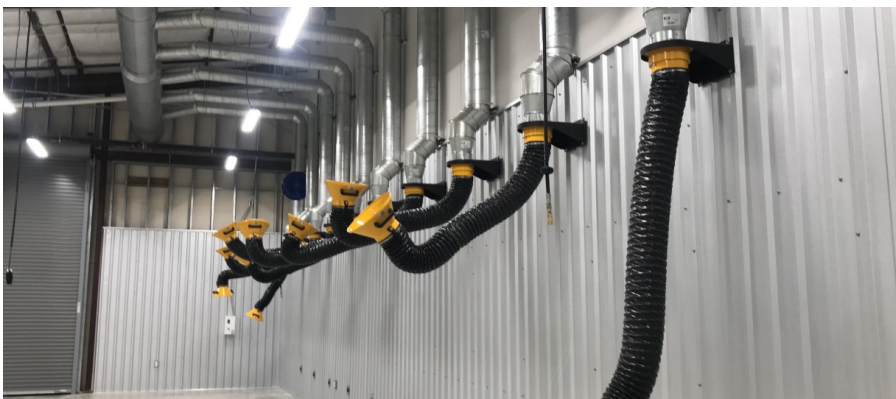

The Annex is very close to being completed! Final sign off will be when all Signage is installed and the Air Compressor installation is fully complete. Expected to be completed before September 26, 2019.



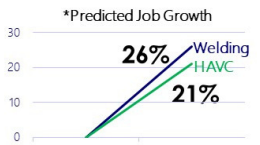
James W. Danner, Sr., Annex Building Sponsorship up to \$90,000. We still need \$62,000.
