*METHODS OF DISCHARGING FINES:

We urge you to Contact the Court if you are unable to pay the amount owed without undue hardship to yourself or your dependents. You may request a hearing before a Judge to consider your ability to pay and request any non-monetary compliance options available to you. You should be prepared to explain and document your financial situation to the Court.

Note: Failure to appear by the appearance date on your citation/summons will result in a warrant issued as well as your driver's license and/or vehicle registration being placed on hold.

- CDL holders should contact the court to discuss options available to resolve citation.
- Individuals under the age of 16 **MUST** appear in open court (in person/virtually). No in person proceedings are available due to age restrictions.
- Contact the court to request defensive driving, probation and payment plans. Community service requests must be made at your court appearance date (no exceptions).

****If you require an accommodation for a physical disability, please contact the court prior to your appearance date so accommodations can be made.****

You may pay/resolve your citation prior to your court date. Contact the clerk for more information. If you choose to pay the citation you can do so by mail, in person or online at www.hondo-tx.org. If paying in person or by mail, personal checks **WILL NOT** be accepted.

If you choose to plea by mail fill out the form on the back page and mail in to the court by your court date. Choose only ONE plea. If you are pleading guilty or nolo contendere (no contest) you may include your payment at that time. If you are pleading Not Guilty, court personnel will contact you once your plea is received.

COMPLAINTS OR COMPLIMENTS: If you wish to compliment or make a complaint against the actions of a Hondo Police Officer, or feel you are a victim of racial profiling, please; Appear in person at the Hondo Police Station located at 1030 Ave Y, Hondo, TX 78861 and request to speak with a supervisor or to obtain a compliment or complaint form; contact the Hondo Police Department by telephone at (830) 426-5353 and request to speak with a supervisor. Complaint forms must be notarized. If you are unable to pick one up in person, please request one to be mailed to you via US Mail and it may be returned via US Mail or in person.

****If you are convicted of a Class C Assault by Contact Family Violence charge it may be unlawful for you to possess or purchase a firearm pursuant to federal law under 18 U.S.C. Section 922 (g)(9) or section 46.04(b) Texas Penal Code. If you have any questions whether these laws make it illegal for you to possess or purchase a firearm, you should contact an attorney.****
