

ORDINANCE NO. 1176-05-18

AN ORDINANCE ESTABLISHING AND RATIFYING THE SPEED LIMITS FOR SPECIFIC STREETS LOCATED WITHIN THE BOUNDARIES OF CITY OF HONDO; ESTABLISHING PENALTY; REPEALING ALL PARTS OF ORDINANCES IN CONFLICT; PROVIDING A SEVERABILITY CLAUSE; AND OPEN MEETINGS CLAUSE; AND PROVIDING FOR RELATED MATTERS.

WHEREAS, the regulation of traffic, motor vehicles and conveyances upon all public streets, roadway and right-of-ways within the City limits of the City of Hondo (the "City") is essential and necessary to protect the traveling public and to preserve and protect the public safety of the City; and

WHEREAS, Section 311.001 of the Transportation Code provides that a home-rule municipality has exclusive control over and under the public highways, streets, and alleys of the municipality; and

WHEREAS, Section 12.04.192 of the City of Hondo Code of Ordinances provides for the city council to adopt speed limits on specific streets; and

WHEREAS, the city staff has conducted an inventory of the City's existing speed limit signs located throughout the City and now recommends the adoption of the list speed limits signs for the specific streets as included herein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HONDO:

SECTION 1. Adoption. Pursuant Section 12.04.192 of the City of Hondo Code of Ordinances, the City Council hereby adopts the following:

A. Speed Limits: The following speed limits are hereby adopted for the streets listed below. Speed limits signs are authorized and shall be erected and maintained by the city at the following locations:

SECTION 2. Recitals. The City Council finds the recitals contained in the preamble to this ordinance are true and correct and incorporates them for all purposes.

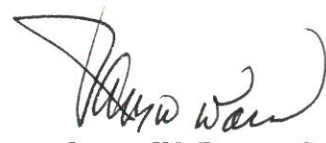
SECTION 3. Penalty. Any person violating any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall be subject to a fine in no to exceed \$500 in accordance with the general penalty provision found in section 1.01.009 of the City of Hondo Code of Ordinances for each offense. In the event of a conflict or inconsistency between this ordinance and any other resolution, code or ordinance of the City, or parts thereof, the terms and provisions of this ordinance shall govern.

SECTION 4. Severability. If any provision of this Ordinance or the application of any provision to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications hereof which can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.

SECTION 5. Open Meetings. That it is hereby officially found and determined that the meeting at which this Ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as a required by the Open Meetings Act, Chapter 551, Local Government Code.

SECTION 6. Effective Date. This ordinance shall be effective from and after its approval and passage in accordance with the Texas Local Government Code and the city charter.
