

ORDINANCE NO. 1182-08-18

AN ORDINANCE AMENDING ORDINANCE 1014-03-14 AWARDING AN EXCLUSIVE FRANCHISE CONTRACT WITHIN THE CITY OF HONDO TO ACI RECYCLING AND DISPOSAL (FORMERLY ALAMO1) FOR THE COLLECTION, HAULING AND DISPOSAL OF RESIDENTIAL, COMMERCIAL AND INDUSTRIAL SOLID WASTE; AMENDMENT WILL EXTEND THE CONTRACT FOUR YEARS WITH ONE YEAR OPTION AND ESTABLISH A CENTRAL RECYCLE LOCATION FOR RESIDENTS OF HONDO; AUTHORIZING THE CITY MANAGER OF THE CITY OF HONDO TO EXECUTE THE CONTRACT AND TO ESTABLISH AN EFFECTIVE DATE.

WHEREAS, the City Council entered into a solid waste disposal contract with Alamo1, pursuant to Ordinance 932-05-10 and such contract has been amended by City Council by Ordinance 1014-03-14 which extended the contract until September 20, 2018; and

WHEREAS, Ordinance 1014-03-14 needs to be amended to extend the contract with ACI Recycling and Disposal (formerly Alamo 1) for an additional period agreed to by the City and ACI; and

WHEREAS, the City Council has determined that there is a need for a Central recycling location for the residents of Hondo and ACI has agreed to provide such a recycling site at no charge to the City or its residents; and

WHEREAS, the City Council of the City of Hondo has determined that such contract is necessary to preserve or protect the public health of the citizens of Hondo, Medina County, Texas;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HONDO, TEXAS, THAT:

SECTION 1. Ordinance 1014-03-14 shall be amended as follows:

2. Term of Contract: The extended term of this Contract will be for four (4) years. This Contract shall become effective and be in force as of October 1, 2018, and terminating on September 30, 2022; provided, however, this Contract may be automatically EXTENDED AT the end of the initial four (4) year term on the anniversary date, for an additional one (1) year term, unless City gives Contractor written notice of termination at least 120 days prior to September 30, 2022 or September 30th of the extended term.

7. Services Required of Contractor

a. Residential Service

f. (1) ACI will charge the following for the first year of the Contract:

Central Recycling Location	N/A	No Charge

f. (2) There will not CPI increase for the first year of the contract. After the first year, the fees shall be adjusted upward to reflect changes in the cost of operations, as reflected by fluctuation in the Consumer Price Index (U) for all Urban Consumers, All U.S. City Average, All Items, as published by the U.S. Department of Labor Bureau of Labor Statistics using the changes in the twelve month period March to March. The Monthly Customer Service charge shall be subject to annual review to ensure revenues offset costs.

i. ACI will provide a Central Recycle Location for the residents of Hondo. At this location, will be a Roll Off Container for the residents to utilize when disposing of their recyclable materials. There will no charge to residents during the specific days and hours. Such Center shall be established within six (6) months of the first year extension.

SECTION 2. The remainder of Ordinance 932-05-10 and Ordinance 1014-03-14 not in conflict with this Ordinance shall remain unchanged and in effect.

SECTION 3. Severability: If any portion of this Ordinance shall, for any reason, be declared invalid, invalidity shall not affect the remaining provisions thereof.

SECTION 4. Repealer: All Ordinances, parts of Ordinances or Resolutions in conflict herewith are expressly repealed.
