

ORDINANCE NO. 1202-06-19

AN ORDINANCE OF THE CITY OF HONDO, TEXAS (CITY) AMENDING ORDINANCE 1186-09-18 "FEE SCHEDULE" BY REVISING FEES FOR CODE & DEVELOPMENT USES AND UPDATING FEE SCHEDULE TO REFLECT FEES APPROVED UNDER PRIOR ORDINANCES; PROVIDING A REPEALER CLAUSE; PROVIDING FOR SEVERABILITY AND SETTING AND EFFECTIVE DATE.

WHEREAS, the City of Hondo adopted Ordinance 1186-06-19 on September 10, 2018, which amended the comprehensive "Fee Schedule" which sets forth the cost of all services provided to the citizens and businesses of the City; and

WHEREAS, the city council has subsequently approved various ordinance adjusting the fees for various city services and permits; and

WHEREAS, H.B. 852 was approved on May 21, 2019, and immediately prohibited cities from calculating residential permit fees based on the value of the improvements; and

WHEREAS, the City of Hondo City Council considers it reasonable to amend said Fee Schedule periodically to reflect the cost of providing city services;

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HONDO, TEXAS**

**SECTION 1. AUTHORIZATION.** That the amended Fee Schedule is attached hereto and made part of this Ordinance and to be set forth in the City's Code of Ordinances as Appendix A, with an effective date upon the passage of this Ordinance, and repealing all previous ordinances in conflict with this Ordinance. In the case of a fee listed in another ordinance, but not included in the amended Fee Schedule, the previous listed fee amount shall apply until amended. All other provisions of the ordinances of the City of Hondo, whether codified or uncodified, which are not in conflict with the provisions of this Ordinance, shall remain in full force and effect.

**SECTION 2. PUBLIC PURPOSE.** The City declares the consolidation of its municipal fees and charges is in the public interest.

**SECTION 3. EFFECTIVE DATE.** This ordinance shall take effect upon passage.

### **FEE SCHEDULE**

Fee rate for residential permitting at \$0.38 (thirty-eight cents) per square foot plus Bureau Veritas rate to comply with H.B. 852, to include fees for alteration/addition for residential construction; building, mechanical, electrical, plumbing, fuel gas and similar, \$100.00 per trade and; other types not listed above \$160 per trade.
