Notice is hereby given in accordance with order of the Office of the Governor issued March 16, 2020, the City of Hondo Economic Development Corporation of the city of Hondo will conduct a Special Meeting scheduled for 4:00 p.m. on April 15, 2020, located in the City Council Chambers, City Hall at 1600 Avenue M, Hondo, Texas. In compliance with the state and federal health emergency declarations, as amended, there will be no public access to the City Council Chamber Chambers. This restriction is intended to advance the public health goal of limiting in-person contact (also called “social distancing”) and thereby slow the spread of the novel coronavirus (COVID-19).

The meeting will be broadcast in the plaza outside of the City Council Chambers. Persons listening to the broadcast in the plaza will be limited to 10 persons.
