The following items will be discussed, to-wit:

- 8) Discuss and consider the approval of the September 24, 2012 Regular Meeting minutes.
- 9) Hold a Public Hearing on the creation of a Reinvestment Zone to encourage economic development.
- 10) Discuss and consider Ordinance No. 967-10-12, an ordinance of the City of Hondo designating the City of Hondo municipal boundaries of the City as a Reinvestment Zone for economic development purposes, establishing the boundaries, providing for severability and providing for an effective date.
