

**ORDINANCE NO. 1162-04-18**

**AN ORDINANCE OF THE CITY OF HONDO, TEXAS ESTABLISHING THE LOCATION OF FOUR-WAY STOP INTERSECTIONS PURSUANT TO SECTION 12.04.092 OF THE CITY CODE OF ORDINANCES; ESTABLISHING PENALTY; REPEALING ALL PARTS OF ORDINANCES IN CONFLICT; PROVIDING A SEVERABILITY CLAUSE; AND OPEN MEETINGS CLAUSE; AND PROVIDING FOR RELATED MATTERS.**

**WHEREAS**, the regulation of traffic, motor vehicles and conveyances upon all public streets, roadway and right-of-ways within the City limits of the City of Hondo (the "City") is essential and necessary to protect the traveling public and to preserve and protect the public safety of the City; and

**WHEREAS**, Section 311.001 of the Transportation Code provides that a home-rule municipality has exclusive control over and under the public highways, streets, and alleys of the municipality; and

**WHEREAS**, the City of Hondo, Texas is a Home Rule City located in Medina County Texas, created in accordance with provision of Texas Local Government Code and operating pursuant to the enabling legislation of the State of Texas; and

**WHEREAS**, Section 12.04.092 of the City of Hondo Code of Ordinances provides for the city council to adopt the listing of all current and future four-way stop intersections as recommended by the city manager; and

**WHEREAS**, the city staff has conducted an inventory of the City's current four-way stop intersections located throughout the City and the city manager recommends the adoption of the list of four-way stop intersections included herein.

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HONDO, TEXAS:**

**SECTION 1. Adoption.** Pursuant Section 12.04.092 of the City of Hondo Code of Ordinances, the City Council hereby adopts the following Four-Way Stop Intersection locations:

27th St	Avenue P

22nd St	Avenue I
Avenue O	27th St
Avenue P	18th St

**SECTION 2. Recitals.** The City Council finds the recitals contained in the preamble to this ordinance are true and correct and incorporates them for all purposes.

**SECTION 3. Penalty.** Any person violating any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall be subject to a fine in accordance with the general penalty provision found in section 1.01.009 of the City of Hondo Code of Ordinances for each offense. In the event of a conflict or inconsistency between this ordinance and any other resolution, code or ordinance of the City, or parts thereof, the terms and provisions of this ordinance shall govern.

**SECTION 4. Severability.** If any provision of this Ordinance or the application of any provision to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications hereof which can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.

**SECTION 5. Open Meetings.** That it is hereby officially found and determined that the meeting at which this Ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as a required by the Open Meetings Act, Chapter 551, Local Government Code.

**SECTION 6. Effective Date.** This ordinance shall be effective from and after its approval and passage in accordance with the Texas Local Government Code and the city charter.
