

ORDINANCE NO. 1187-09-18

AN ORDINANCE ADOPTING AND REPEALING SCHOOL CROSSING ZONES FOR SPECIFIC STREETS LOCATED WITHIN THE BOUNDARIES OF THE CITY OF HONDO; ESTABLISHING PENALTY; PROVIDING A SEVERABILITY CLAUSE; AN OPEN MEETINGS CLAUSE; SETTING AN EFFECTIVE DATE AND PROVIDING FOR RELATED MATTERS.

WHEREAS, the regulation of traffic, motor vehicles and conveyances upon all public streets, roadway and right-of-ways within the City limits of the City of Hondo (the "City") is essential and necessary to protect the traveling public and to preserve and protect the public safety of the City; and

WHEREAS, Section 12.04.162 of the City of Hondo Code of Ordinances provides for the city council to adopt school crossing zones on specific streets located within the boundaries of the city; and

WHEREAS, the city staff and police have conducted an inventory of the city's existing school crossing zones located throughout the City and now recommend the adoption of the list of school crossing zones for the specific streets as included herein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HONDO:

SECTION 1. Adoption and Repeal. Pursuant Section 12.04.162 of the City of Hondo Code of Ordinances, the City Council hereby adopts the following:

- A. Adopted School Crossing Zones: The following school crossing zones are hereby adopted for the locations listed below:

SECTION 2. Recitals. The City Council finds the recitals contained in the preamble to this ordinance are true and correct and incorporates them for all purposes.


SECTION 3. Penalty. Any person violating any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall be subject to a fine in no to exceed \$500 in accordance with the general penalty provision found in section 1.01.009 of the City of Hondo Code of Ordinances for each offense. In the event of a conflict or inconsistency between this ordinance and any other resolution, code or ordinance of the City, or parts thereof, the terms and provisions of this ordinance shall govern.

SECTION 4. Severability. If any provision of this Ordinance or the application of any provision to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications hereof which can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.

SECTION 5. Open Meetings. That it is hereby officially found and determined that the meeting at which this Ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as a required by the Open Meetings Act, Chapter 551, Local Government Code.

SECTION 6. Effective Date. This ordinance shall be effective from and after its approval and passage in accordance with the Texas Local Government Code and the city charter.
