

ORDINANCE NO. 1015-03-14

AN ORDINANCE AMENDING SCHEDULE "A" OF ORDINANCE NO. 996-09-13, AWARING AN EXCLUSIVE FRANCHISE CONTRACT WITHIN THE CITY OF HONDO, MEDINA COUNTY TEXAS TO ALAMO1, FOR THE COLLECTION AND DISPOSAL OF RESIDENTIAL, COMMERCIAL AND INDUSTRIAL SOLID WASTE, IN ORDER TO CHANGE THE MONTHLY RATES FOR CITY OF HONDO RESIDENTIAL, BUSINESS/PROFESSIONAL SHOPS, AND COMMERCIAL USERS.

WHEREAS, the City of Hondo's Solid Waste Disposal Contractor, Alamo1, has offered to reduce its fees charged to the City of Hondo for the collection and disposal of residential, commercial and industrial solid waste pursuant to its Franchise Contract (Ordinance No. 932-05-10); and

WHEREAS, the relevant portions of Exhibit "A" of Ordinance 996-09-13, need to be amended to reflect the decreased rates offered by Alamo1; and

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF HONDO, TEXAS:

Schedule "A" of Ordinance No. 996-09-13 shall be amended as follows:

Residential:

One Waste Wheeler	\$17.68
Two Wheelers	\$26.86
Three Wheelers	\$35.58

Business/Professional Shops Waste Wheelers:

One Waste Wheeler	\$26.80
Two Waste Wheelers	\$35.72
Three Waste Wheelers	\$44.66

Waste Wheeler service for Residential and Business/Professional Shops for less than 16 days of any month will be billed at one-half (1/2) the above rates for that month.




SECTION 2. The effective dates of these amended rates shall be for services provided beginning in March 2014
