

ORDINANCE NO. 1023-06-14

**AN ORDINANCE, PROVIDING FOR THE DISANNEXATION FROM THE CORPORATE BOUNDARIES OF THE CITY OF HONDO, TEXAS, BEING APPROXIMATELY 29.51 ACRES FROM A 325.99 ACRE TRACT OF LAND BEING SITUATED PARTIALLY IN THE CITY LIMITS OF HONDO, BEING APPROXIMATELY 161.17 ACRES OUT OF SURVEY NO. 190, ABSTRACT NO. 795, MEDINA COUNTY, TEXAS, PURSUANT TO THE PETITION FOR DISANNEXATION BY TREY & KATY BADER.**

**WHEREAS**, the City Council of the City of Hondo, Texas, has received a Petition for Disannexation from Trey and Katie Bader (the "Petition") regarding a 29.51 acre tract of land, more or less, and said request was presented to the City Council on the 12<sup>th</sup> day of May, 2014, and the 23<sup>rd</sup> day of June 23, 2014;

**WHEREAS**, after hearing such request and the arguments for and against the same and City Council has voted to grant such petition and to deannex said acreage from the City of Hondo, Texas;

**WHEREAS**, Chapter 43 of the Texas Local Government Code and Section 12.01 of the Charter of the City of Hondo, Texas, authorizes the disannexation of territory subject the laws of this state; and

**WHEREAS**, the City Council hereby further finds and determines that the disannexation of the 29.51 acre tract, more or less, requested by the owners, Trey and Katie Bader is necessary and appropriate and in the best interests of the City.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HONDO, TEXAS:**

The below described tract of land being approximately 29.51 acres from a 325.99 acre tract of land being situated partially in the city limits of Hondo, being approximately 161.17 acres out of Survey No. 190, Abstract No. 795, Medina County, Texas, is hereby disannexed and discontinued from the corporate limits of the City of Hondo, Texas. Said tract of land hereby disannexed and discontinued from the City of Hondo, Texas, is more particularly described by the plat attached hereto, and incorporated in the legal description of the entire 325.99 acre tract collectively herein as Exhibit "A" and made part of this ordinance.


The City Secretary is hereby directed to file with the County Clerk of Hondo, Texas a certified copy of this ordinance.

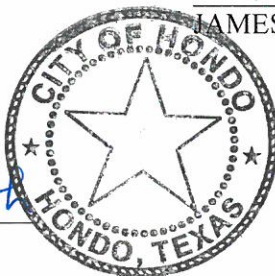
