

**ORDINANCE NO. 1030-07-14**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HONDO, TEXAS AMENDING THE CODE OF ORDINANCES APPENDIX A, "FEE SCHEDULE", ARTICLE A13.000 "UTILITIES", DIVISION 4 "SOLID WASTE RATES AND CHARGES", SECTION A13.111 "SCHEDULE OF RATES AND CHARGES" TO INCLUDE SUBSECTION (c) "SCHEDULE C. PERMIT FEES FOR CITIZEN'S COLLECTION STATION" TO INCREASE THE YEARLY PERMIT FEE; TO PROVIDE FOR A ONE-TIME USE FEE; TO CODIFY SAID FEES IN THE CITY'S CODE OF ORDINANCES; AND TO PROVIDE FOR A SEVERABILITY CLAUSE AND EFFECTIVE DATE.**

**WHEREAS**, City Council of the City of Hondo, has determined that it is necessary to increase the yearly permit fee for the use of the Citizen's Collection Station ("Collection Station"), to provide for a one-time use permit fee, and to codify said fees in the City's Code of Ordinances; and

**WHEREAS**, the City Council of the City of Hondo deems it to be in the best interest of the citizens of Hondo to increase the yearly permit fee from \$20.00 per year to \$30.00 per year and to provide a one-time use permit fee of \$20.00.

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF HONDO, TEXAS:**

**Section 1.** That the Fee Schedule in Appendix A, Article A13.000 "Utilities", Division 4, Section A13.111 is hereby amended to include subdivision (c) to increase the yearly permit fee for the Collection Station and to provide a one-time use permit fee of \$20.000 as described below:

(c) Schedule C. Permit Fees for Citizens Collection Station.

Yearly Permit Fee:	\$30.00 per person
One-Time Use Fee:	\$20.00 per person

**Section 3.**

The amended yearly permit fee and the one-time use permit fee rates shall start on July 14, 2014.

**Section 4.**

This ordinance shall take effect on July 14, 2014.

**Section 5.**

If for any reason any section, paragraph, subsection, clause, phrase, word, or provision of this Ordinance shall be held invalid or unconstitutional by final judgment of a Court of competent


